 **12/30/50 MILE ROUTES**

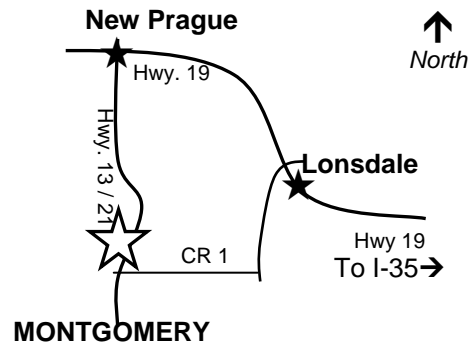
Come and join us for a ride through scenic Le Sueur County. The Tour de Bun will consist of two routes with three loops: a 12-mile, a 30-mile and a 50-mile loop. Each route will have refreshment stops at various points and will provide scenic rural countryside on paved, lightly traveled roads.

 **LOCATION**

Montgomery is a short drive south of the Twin Cities, located 20 miles south of Prior Lake on MN Hwy. 13, and 20 miles northwest of Faribault.
